

**ENROLLMENT:**

There is a registration fee of \$20 per dancer. If you have more than one dancer enrolling, each additional dancer's annual registration fee is \$10. Registration fees are non-refundable, and are due at the time of enrollment.

**TUITION:**

Tuition is charged per month and is calculated by the amount of hours, per week, your dancer attends. Tuition payments are due on the **1st of each month**. Any account that is **10 days past due**, regardless of class cancellation, student illness, vacations, etc. will be charged a **\$10 late fee**. Families pay full tuition for the dancer enrolled with the most hours, per week, and then will receive a **10% discount** on each additional child's tuition. Monthly payments can be made on-line via credit/debit, or at the studio via check, cash, or credit/debit. There is a **3% service/transaction fee** when paying with a credit card, making an on-line payment, and for auto pay accounts. This fee will automatically be applied to the account. If dancers are members of the Infinity Dance Academy Competitive Team, competitive and miscellaneous fees will vary and will be provide at competitive team registration. Checks should be made payable to: Infinity Dance Academy. (\$30 fee for all returned checks). Optional payment plans for your annual tuition are below:

- **MONTHLY**- Monthly payments are due on the 1st of each month.
- **TRIMESTER**- The trimester plan offers a discount by paying three months at a time. Payments are due by September 5th, December 5th and March 5th. This is a 5% discount off of the monthly fees. The trimester plan is only available until each of these payment deadlines. Once each deadline has passed, the rate is no longer available.
- **YEARLY** – Yearly payment is due September 10th. You will receive 10% off your annual classroom tuition.

**CLASSES/CANCELLATIONS:**

Our class schedule can be found on our website. We will not have classes during holiday breaks and follow the USD 368 cancellations. There are **NO** refunds or prorates to tuition for scheduled breaks and holidays. Classes with fewer than 4 students may be combined or cancelled; you will be notified and assisted in finding a replacement class if this were to occur. No refunds will be made for students, who for any reason, do not come to class. In case of Inclement Weather Cancellations, classes will not be in session when the USD 368 School District is dismissed due to inclement weather. This includes early dismissal due to weather conditions. There are **NO** refunds on tuition for inclement weather cancelations. **CLASS RULES:**

Students are expected to attend all classes. Frequent absences hold back other students in the class. If you miss a lesson, you are welcome and encouraged to make it up. Please ask your instructor for your make-up class. We reserve the right to dismiss any student whose attendance, attitude or conduct is found unsatisfactory. Children not in class (siblings, etc) need to be under parental supervision at all times. Tap shoes are allowed only in the dance rooms.

**MAKE-UP CLASSES:**

Students may make-up classes in the event of illness and emergencies. Classes must be made-up within the month of absence and may not be accumulated. This policy is in effect to ensure the integrity of the classes and promote regular attendance. Please note: Make-up classes are not provided in the instance of inclement weather. In addition, we reserve the right to cancel a class if less than four students are in attendance or if the instructor is unable to attend. In both of these cases, an appropriate make-up class will be assigned.

**WITHDRAWAL/REFUNDS:**

A one months notice from the first of the month is required to discontinue any classes. Should withdrawal from a class become necessary, you must notify the office via email. Until such notification, the space will be held for the student and charges will continue to be invoiced to the account.

**OUTSTANDING ACCOUNTS/BALANCES:**

After 60 days of an outstanding account balance, the account will be charged an additional \$50 late fee per month. All accounts must be paid in full by the annual recital date. There are no refunds on tuition.

**RECITAL/COSTUMES:**

All recital classes are featured in the annual recital. Due to the cost of producing a recital, there is a \$40 non-refundable recital fee per dancer due by March 1st. If you are in a recital class, the cost for recital costumes is \$70 per child. If dancers are in more than one recital class per week, please make a costume payment for each class. If dancers are members of the Infinity Dance Academy Competitive Team, competitive costumes, accessories, and miscellaneous fees will vary and will be provide at competitive team registration. All costume fees are non-refundable and due by NOV 30th. Please wear your recital costume to the recital rehearsal as well as the recital. Recital t-shirts are available for purchase. If you are interested, check at the front desk in April to place your order.

**PHOTO RELEASE:**

Infinity Dance Academy is hereby granted permission to take photographs of the students to use on web sites, advertisements, and other materials the studio creates. Permission is granted for Infinity Dance Academy to copyright photographs in its name. No financial compensation will be given for use of any photograph or video.

We reserve the right to not use the video or photos at the time they are taken, but at our discretion at a later date. Infinity Dance Academy reserves the right to discontinue use of photos or video without notice.

**LOST&FOUND:**

It is highly recommended that you mark your students belongings with his/her name, as Infinity Dance Academy is not responsible for lost or stolen items of personal property. A lost and found will be located at the studio desk. Please check for lost belongings frequently, as it is cleaned out at the end of each month. Leftover items are donated to charity.

**RESPONSIBILITIES:**

It is the responsibility of the parents or adult students to inform the studio of address or telephone number changes and to arrive to class on time. If your student is late for class we just ask that they be respectful upon entering. It is also your responsibility to drop off and pick your child up at proper time. We ask that students are dropped off and picked up **no more than 10 minutes before and after** their scheduled class times. Please have your student(s) wait inside for pick up for their own safety.
